Welcome and Introductions by Nonie Brennan

Consuella Brown proposed the question: What is one thing that you would like to come away with from this meeting? Some of the responses were:

- Who will the lead agency be?
- Who will be the best leading agency?
- How can we support?
- How do we all work together?
- How will the entire system be funded?
- What is this opportunity about?
- What will the Youth Advisory Board look like?

Consuella Brown provided the purpose of the meeting

Overview of the NOFA provided by Dave Thomas

- Mentioned it is very important that everyone read the NOFA
- Appendix A & B would be helpful to read as well as it dives deeper into the projects
- High level focus on NOFA and mentioned heavily scored portions and the overall idea of the community approach through the grant

Questions presented and comments presented from the NOFA overview:

- Are any capital expenditures allowed? Or Infrastructure support?
- It is going to be a challenge to end youth homelessness by 2020
- Will all of the models be renewable in the CoC competition? Will they be evaluated by them in the HUD competition?
- How can we be inclusive of other needs that they youth need to end homelessness? For example, mental health
- Need HUD to not be narrow minded with this grant and it not just be housing solutions.
- Is HUD committed to this and willing to provide additional resources and supports for the long haul
- What is the big picture and purpose of this grant?
- Are we going to be evaluated as individual or in rural areas or in conjunction?

- What is HUD's commitment in pulling in alternative funding resources?
- Concerns about the time it takes to fund the projects?
- Reunification of families should be included and it should be a large family engagement part in this grant
- We should use existing resources. Can we evaluate transitional housing, drop in centers, low thresholds?
- Can the evaluation process be incorporated?
- Questions regarding the access to data (Youth PIT Count) from the Voices of Youth Count before it is released to the public for this grant purposes
- Chicago has been creative in working with Mental Health Services and other sectors, but have had problems working with CPD in the past
- We play well in the sandbox together!
- Keep in mind that the age 24 is an arbitrary number and many youth homelessness continues well past 24 and what supports will they have. (Maybe a transition plan)
- A lot of strengths in Chicago and the diverse housing models.
- Reminder that there will be the opportunity for rolling project request and that all of the answers and number need to be figured out upfront.

Key Decisions and Suggestions

- Chicago is in. Everyone at the table agreed we should move forward in applying for this grant
- All Chicago will submit the actual application as it is the current Collaborative Applicant for the Continuum
- A Youth Advisory Board will be created
- A lead agency will be chosen through some process
- Process for choosing a lead agency will be decided
- Ask who wants to be the lead agency
- Suggestion that lead agency not be a provider
- Suggestion that the lead agency be neutral and be committed and have knowledge about youth homelessness and the people that are at the table
- Because of timing the lead agency should have an understanding about our system
- Possibly choose an agency that does advocacy
- Possibly choose a researcher or university
- Nonie and Maura described the leadership team that exist for the Veteran's Initiative and that there is no funding available in their coordination. Possibly use a model like this to lead this project. CSH was contracted through the city for the Veterans Imitative
- Note that CSH seems to have a relationship or a part with HUD in this project
- John Egan stressed that the New Project Selection Committee and the Board should be involved in the selection of the lead agency and this grant
- Reminder that the planning grant is not renewable, but may be like the planning grant that already exist. (Treated like a new project every year, but is available)

- Wayne from CCH stated they would start and they can support and recommend what works best
- · Questions around paying the youth and incentives for them to join the board
- Accommodating youth during the evening or weekends
- Can we learn from entities that are already doing this work already?
- Make sure the board is diverse
- All Chicago agreed to possibly do training for the youth
- Possibly have every organization provide one youth and an alternative
- Use youth 18 to 24 so that they can sign the signature page required for the application
- Consuella mentioned a possibility of 15 youth on the advisory board
- How do we develop this board?
- Is there an organization that overseas this board?
- The night ministry has an 11-week youth program with an advisory board.
