Housing Retention and Eviction Prevention – Chapel

This breakout session aims to provide attendees with a high-level overview of Housing First and harm reduction philosophies to level set; strategies for eviction diversion in different types of housing models (project-based vs. scattered site; blended management vs. private market landlords); and an overview of tenant rights. The facilitators will share resources and examples of eviction diversion within their organizations.

Diversions— Moving Toward Creative Problem-Solving – Room #17

Shelter diversion is a creative, problem-solving approach to quickly address a housing crisis. In this session, we will review the practice of diversion, the need for diversion, the Diversion Workgroup's strategy to roll out diversion system-wide (still in progress) and discuss the impact that a strong diversion practice could have on our system.

Chicago Rapid Re-Housing Report Overview – Room #19

Rapid Re-housing (RRH) has become one of the major intervention models used nationwide to respond to homelessness. In April 2019, All Chicago released a report, which is the first comprehensive review of RRH in Chicago. Using HMIS data, the report analyzes all RRH projects in Chicago between 2014-2017. The presentation will cover the major points of the report including an RRH overview, demographic data, program outcomes, and policy recommendations. There will also be time for questions and group discussion about the report.
