Lori E. Lightfoot

Mayor of Chicago

Lori E. Lightfoot is the 56th Mayor of Chicago.

Since assuming office following her historic election, Mayor Lightfoot has undertaken an ambitious agenda of expanding opportunity and inclusive economic growth across Chicago's neighborhoods and communities, with early accomplishments including landmark ethics and good governance reforms, worker protection legislation, and closing

a record \$838 million budget gap, as well as key investments in education, public safety and financial stability. Mayor Lightfoot also placed Chicago on the path to a \$15 minimum wage by 2021.

In response to the unprecedented COVID-19 crisis, Mayor Lightfoot has led a coordinated, citywide response across government, business, and community organizations to effectively address its spread and broader public impact, including the creation of the Racial Equity Rapid Response Team, the COVID-19 Recovery Task Force, among other actions.

Prior to her election, Mayor Lightfoot most recently served as a senior equity partner in the Litigation and Conflict Resolution Group at Mayer Brown. Previously, she served as President of the Chicago Police Board, as well as the Chair of the Police Accountability Task Force.

Mayor Lightfoot also served as Chief of Staff and General Counsel of the Chicago Office of Emergency Management and Communications, interim First Deputy of the Chicago Department of Procurement Services, Chief Administrator of the Office of Professional Standards, and as Assistant United States Attorney.

A native of Massillon, Ohio, Mayor Lightfoot has been a resident of Chicago since 1986 and lives on the Near Northwest Side with her wife Amy Eshleman and their daughter.

Peter Vilim

Vice Chairman and Co-Founder, Waterton

Pete serves as Vice Chairman of Waterton, a Chicago-based national investment manager specializing in apartment communities. Since assuming the role of Vice Chairman, Pete spends increasing time managing Waterton's philanthropic and civic engagement, focusing on ending homelessness and providing affordable housing.

Prior to co-founding Waterton in 1995, Mr. Vilim was an investment officer with two other national apartment investment managers, Berkshire Realty Company, Inc., and AMLI Realty Co. Pete started his career as a certified public accountant, working in the national real estate tax practice departments of both Coopers & Lybrand and Peat Marwick Mitchell.

Mr. Vilim holds a bachelor's degree in accountancy from the University of Illinois and a master's degree in taxation from DePaul University. In addition to his continuing activity on the All Chicago board, Pete serves on the Board of Directors, and is Chairman of the Finance Committee for the Housing Partnership Equity Trust ("HPET"), a social purpose real estate investment trust owning and operating affordable apartments nationally. Locally, Pete is on the President's Advisory Council for Mercy Housing Lakefront, The Advisory Council for Housing Opportunities for Women, a member of the Business Council of the Institute on Global Homelessness and sits on the Property Committee of Bridge Communities, a transitional housing provider in DuPage County.

System Impact Award

Chicago Homelessness and Health Response Group for Equity (CHHRGE)

The Chicago Homelessness and Health Response Group for Equity (CHHRGE – pronounced “Charge”) is a cross-sector partnership created to address COVID-19 among vulnerably housed populations of Chicago. The group first

came together on March 13, 2020, when seven people consisting of homeless service providers, faculty, students, and staff from Rush University Medical Center convened to discuss the implications of COVID-19 on guests at Franciscan Outreach shelters on Chicago’s West Side.

The group recognized that public health guidelines for social distancing would put shelter guests at considerable risk unless urgent actions were taken. Seven priorities were identified as immediate actions for serving vulnerably housed individuals at Franciscan Outreach. Within one month, daily calls included 100+ members from healthcare, service, and government agencies across the City of Chicago coming together to support vulnerably housed populations. The collaborative became known as the West Side Homeless COVID-19 Response Group and was later renamed the Chicago Homelessness and Health Response Group for Equity (CHHRGE) as the group’s membership and scope of concern had evolved.

CHHRGE responded quickly to COVID-19 and jumped into action to serve people experiencing homelessness and address the unique risks they face during a pandemic. Working closely with the City of Chicago, the group has accomplished several key milestones in a short amount of time, including building a medical respite unit, repurposing a downtown hotel to shield high-risk people experiencing homelessness from COVID-19, and creating rapid response COVID-19 testing teams.

Dr. Steven K. Rothschild, M.D.

Rush University

Steven K. Rothschild, MD, is a family physician, educator and researcher in the Departments of Preventive Medicine and Family Medicine at Rush University. In addition to a 30-year clinical career focused on providing primary medical care to the medically underserved, he is an established researcher focusing on health services research, chronic illness self-management, and community- and team-based approaches to addressing health disparities. As an expert in community based participatory research, he has been an invited faculty member for the NIH Summer Institute on Design and Conduct of Randomized Clinical Trials involving behavioral interventions, sponsored by the Office of Behavioral and Social Sciences Research. As a faculty member at Rush, he has been recognized by students for his teaching excellence and humanism. He is also the co-convener of Rush's interprofessionalism interest group, bringing together over 30 clinicians and faculty from across the Medical Center to improve team-based education, research and patient care. Rothschild serves on the Chicago Board of Health, the advisory committee for the Albert Schweitzer Fellowship Program, and the Health and Medicine Policy Research Group, where he is vice president.

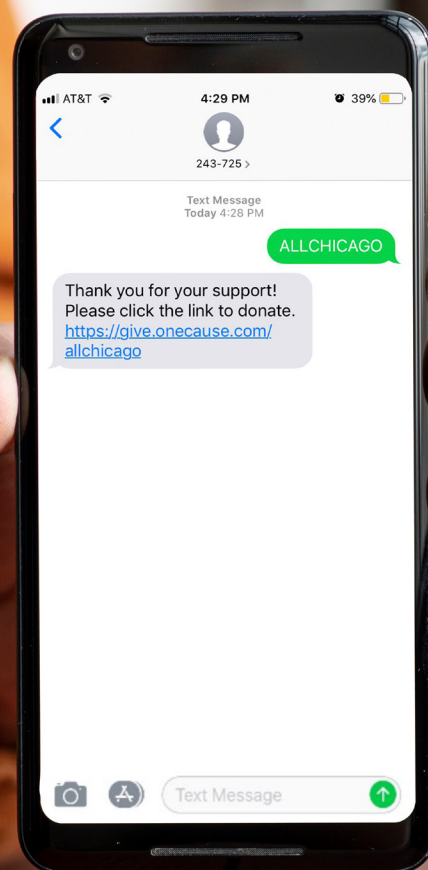
