The Health Equity Affinity Group sits within CHHRGE. Chicago Homelessness and Health Response Group for Equity is focused on health equity and racial equity. The Health Equity Affinity Group will work to address the healthcare needs of people experiencing homelessness, and we define healthcare broadly to include mental health, substance use treatment and harm reduction, vision and dental care, and other wrap-around services.
